



SCHOLARSHIP FUND REIMBURSEMENT PROGRAM

WHO MAY APPLY?

Any Pulice Construction, Inc., Roadway Electric LLC, or McNeil Brothers, Inc. employee who has worked a minimum of 500 hours, or a dependent of the qualified employee, who will be enrolling in an academic institution of higher learning (i.e. college, vocational school, etc.) for the upcoming school year. This is a reimbursement program for tuition and/or books up to the amount you may be awarded. Receipts must be submitted by the end of the award school year.

HOW WILL THE APPLICATION BE JUDGED?

Selections will be based on the general worthiness of the application; however, a higher priority will be given to employees. The scholarship Committee will consider: (1) Scholastic standing, (2) Career goals (and if it relates to heavy highway construction), and (3) Essay written by the candidate. Thoroughness of the completed application will have a bearing on the scoring by the committee, with an emphasis on the written essay. Incomplete applications may be subject to deduction or disqualification.

HOW DO I APPLY?

All applicants must complete the application form and essay in accordance with the instructions and send to the Pulice Companies Scholarship Fund Committee, Attn: Mimi Berryman (Director of Human Resources), at 2033 West Mountain View Road, Phoenix, AZ, 85021.

Applicants must also submit proof of grades with their application form and essay to show school progress and completion of the prior term.

WHEN MUST I APPLY?

The number of scholarships and dollar amounts awarded each year will be at the sole discretion of the Scholarship Fund Committee. Typical dollar amounts awarded to selected applicants may range from \$250 to \$2,500.
